Sub: Intimation regarding a safety incident on April 27, 2025, at Lyfius Pharma Private Limited (a wholly owned stepdown subsidiary of the Company).

Pursuant to Regulation 30 of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 this is to inform you that –

On April 27, 2025, at approximately 10:00 PM (IST), a fire incident occurred in the vicinity of the coal crusher area at our Penicillin-G manufacturing facility located in Kakinada SEZ, Thondangi (M), Kakinada District - 533449, Andhra Pradesh, India. The incident resulted in damage to certain ancillary equipment, with no impact to the core manufacturing infrastructure. Importantly, there were no injuries reported. The incident is not expected to have material impact on the operations or financials of the group.

A thorough assessment of the damage is currently underway. We would like to reassure all stakeholders that the facility is fully insured. As a precautionary measure and to facilitate necessary equipment replacements, operations at the plant will be temporarily paused for an estimated period of 20 to 25 days. We remain committed to resuming full operations at the earliest while maintaining the highest safety and quality standards.
